LUCIEN BIANCO is a prominent French Sinologist. He has written a dozen books on the history of modern China, its peasantry, and the Chinese Communist Revolution since the publication of his groundbreaking *Les Origines de la révolution chinoise* (1967; available in English as *The Origins of the Chinese Revolution*, Stanford UP, 1971). His most recent publication, *La Récidive: Révolution russe, révolution chinoise* (2014), appeared in English translation as *Stalin and Mao: a Comparison of the Russian and Chinese Revolutions* (The Chinese U of Hong Kong P, 2018).

KIRIL FEFERMAN is Senior Lecturer at the Ariel University (Israel). His research interests focus on World War II, the Holocaust in the occupied Soviet territories, and the history of totalitarianism. His most recent books are *The Holocaust in the Crimea and the North Caucasus* (Yad Vashem Publications, 2016) and *“If We Had Wings We Would Fly to You”: A Soviet Jewish Family Faces Destruction, 1941-42* (Academic Studies P, 2020). *The Holocaust in the Crimea and the North Caucasus* examines Nazi policies toward various Jewish ethnic and religious groups, and the ensuing responses by Jews and local populations, including reactions by Orthodox Christians and Muslims. *“If We Had Wings We Would Fly to You”* explores the intertwined history of a Jewish family, World War II, and the looming destruction.

PETER GRAY is Professor of Modern Irish History and Director of the Institute of Irish Studies at Queen’s University Belfast. He has published widely on the history of the Great Irish Famine of 1845-50 in its political and comparative perspectives, and on British governance of nineteenth-century Ireland. His books include *The Irish Famine* (Thames & Hudson, 1995), *Famine, Land and Politics: British Government and Irish Society 1843-50* (Irish Academic P, 1999), and *The Making of the Irish Poor-Law, 1815-43* (Manchester UP, 2009). He also edited the following volumes: *The Memory of Catastrophe* (Manchester UP, 2004), *Poverty and Welfare in Ireland 1838-1948* (Irish Academic P, 2011), *The Irish Lord Lieutenantcy* (UCD P, 2012) and *The Great Irish Famine and Social Class* (Peter Lang, 2019). Gray is a Member of the Royal Irish Academy and has been a visiting professor at Boston College and the University of New Brunswick.

MICHAEL HECHTER is Foundation Professor of Political Science at Arizona State University (ASU) and Emeritus Professor of Sociology at the University of Washington. A fellow of the American Academy of Arts and Sciences, he is also on the core faculty of ASU's Center for Social Dynamics and Complexity. Previously he taught at the Universities of Washington, Arizona, Oxford, and Copenhagen. His research has principally focused on nationalism, social theory, collective action, and social order. His most recent book (with Steven Pfaff) is *The Genesis of Rebellion: Governance, Grievance and Mutiny in the Age of Sail* (Cambridge UP, 2020).

LYUDMYLA HRYNEVYCH is a senior researcher at the Institute of the History of Ukraine, National Academy of Sciences of Ukraine. She is also a representative of the CIUS's Holodomor Research and Education Consortium in Ukraine, director of the Holodomor Research and Education Centre in Ukraine, and editor-in-chief of the interdisciplinary journal *Holodomor Studies*. Hrynevych's research focuses mainly on Stalin's policies of famine creation in Ukraine in the context of the study of genocide and empires. Her latest book is *Khronika kolektyvizatsii ta Holodomoru v Ukraini, 1927-1933*, vol. 2, book.1 (*A Chronicle of Collectivization and the Holodomor in Ukraine, 1927-1933*, HREC Press, 2016).

DOUGLAS IRVIN-ERICKSON is Assistant Professor at the Jimmy and Rosalynn Carter School for Peace and Conflict Resolution at George Mason University, where he directs the Raphaël Lemkin Genocide Prevention Program. A legal and diplomatic historian and political theorist by training, his research interests include genocide prevention, human rights, and international criminal law. He has written about the Ukrainian genocide, Soviet genocides, and international tribunals including the International Criminal Court (ICC) and the Khmer Rouge tribunal in Cambodia.

BOHDAN KLID is Research Director of the Holodomor Research and Education Consortium (HREC) at the Canadian Institute of Ukrainian Studies (CIUS), University of Alberta. He served as Assistant Director of CIUS from 2001 to 2016. Klid has written articles on the Holodomor and is co-editor, with Alexander Motyl, of *The Holodomor Reader: A Sourcebook on the Famine of 1932-1933 in Ukraine* (CIUS P, 2012). He has also written on the nineteenth-century historian Volodymyr Antonovych, on Ukrainian historiography of the late nineteenth and early twentieth centuries, and on contemporary Ukrainian popular music and politics.

OLEKSANDR LYSENKO holds a PhD in History and is Professor at the Institute of the History of Ukraine at the National Academy of Sciences (NAN) of Ukraine, where he heads the division of the history of Ukraine during World War II. His latest major publication is *Stratehichni ta frontovi operatsii na terytorii Ukrainy 1943-1944 rr. (Strategic and Front Operations on the Territory of Ukraine in 1943-1944)*, co-authored with V. Hrytsiuk, R. Pyliavets', and S. Sydorov (Natsional'nyi universytet oborony Ukrainy im. Ivana Cherniavs'koho and Instytut istorii Ukrainy, NAN Ukrainy, 2015).

OLEKSANDR MAIEVS'KYI is Senior Research Scholar at the Institute of the History of Ukraine, National Academy of Sciences of Ukraine. His research focuses mainly on the study of the meaning of propaganda during World War II in Ukraine. His recent publications include *Politychni plakaty i karykatura yak zasoby ideolohichnoi borot'by v Ukraini 1939-1945 rr. (Political Posters and Caricatures As Means of Ideological Warfare in Ukraine, 1939-1945)*, Instytut istorii Ukrainy, NAN Ukrainy, 2018) and two articles on a related topic in no. 18 (2015) and no. 19 (2017) of *Ukrains'kyi istorychnyi zbirnyk*.

JANAM MUKHERJEE is Associate Professor of History at Ryerson University in Toronto. His book *Hungry Bengal: War, Famine and the End of Empire* (Oxford UP, 2015) is a detailed account of the impacts of hunger and economic violence on the people of undivided Bengal. Incorporating extensive archival and oral history research, Mukherjee draws structural links between war, famine, social upheaval, and civil violence in mid-twentieth century Bengal. Mukherjee has also published theoretical work on structural violence more generally and creative non-fiction related to the period of war, famine, and riots in Bengal.

PAUL A. SHAPIRO is Director of International Affairs and Founding Director (Emeritus) of the Jack, Joseph and Morton Mandel Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum. In 2003-04 he wrote major sections of the *Final Report* of the International Commission on the Holocaust in Romania, chaired by Elie Wiesel. He led the Museum's successful effort to open the archives of the International Tracing Service-Bad Arolsen Archives (Germany) and served on the Interagency Working Group on Nazi War Crimes and Japanese Imperial Government Records, an archival declassification effort mandated by the US Congress. Shapiro's publications include *The Kishinev Ghetto 1941-1942: A Documentary History of the Holocaust in Romania's Contested Borderlands* (U of Alabama P, 2015) and numerous articles and book chapters on Romanian and Holocaust history.

TETIANA ZABOLOTNA is Research Scholar at the Institute of the History of Ukraine, National Academy of Sciences of Ukraine. Her research interests include the daily life of the population during the occupation of Ukraine in World War II. She recently co-authored and compiled the following volume: *Ukraina v Druhii svitovii viini. Pohliad z XXI st. Dokumenty ta materialy. U 2-kh chastynakh (Ukraine in World War II: The View from the XXI Century. Documents and Materials in Two Parts)*, Part 1, Naukova dumka, 2020.
