TYMOFII BRIK is Rector of the Kyiv School of Economics and Roberta Buffett Visiting Professor of International Studies at Northwestern University. He is also a member of PONARS Eurasia and was previously a Fulbright Visiting Scholar at New York University and a Visiting Vucinich Fellow at the Stanford Center for Russian, East European and Eurasian Studies. He serves as an editor at Vox Ukraine and is a board member of CEDOS (an NGO Centre for Society Research). The results of his recent studies have appeared in the *Economic History of Developing Regions*, the *Sociology of Religion*, and as chapters in compilations published by Palgrave Macmillan, Ibidem-Verlag, and Routledge.

He guest-edited a special issue on Ukraine for the film studies' e-journal KinoKultura (2009). Chernetsky is a past president of the American Association for Ukrainian Studies and is currently the first vice president of the Shevchenko Scientific Society in the U.S.

OKSANA DOVGOPOLOVA is Professor in the Department of Philosophy at the Odesa I. I. Mechnikov National University (Ukraine). She has a Dr. Habil. Degree in the Philosophy of History. Her PhD and her Dr. Habil. dissertations concerned "places of the Tolerable, the Alien, and the Rejected" on the metaphorical map of social space. Dovgopolova's research interests include the philosophy of history, memory studies, urban mythology, and social reconciliation in the context of collective memory in Ukraine. JESSICA ZYCHOWICZ is Director of Fulbright Ukraine and the Institute of International Education, Kyiv Office. She recently published a monograph *Superfluous Women: Art, Feminism, and Revolution in Twenty-First Century Ukraine* (U of Toronto P, 2020). The book has been reviewed in multiple languages and in several countries; it won an Honorable Mention for the Omelijan Pritsak Prize for Ukrainian Studies at the Association for Slavic, East European, and Eurasian Studies and an Honorable Mention from the Modern Language Association (MLA) for the Scaglione Prize in Slavic Studies. The book will soon be published in Poland and in Ukraine.
